

Member Contract San Francisco Gay Softball League



Every member including associates must read the Member Contract before signing his/her signature. Managers signing the Member Contract agree that he/she has received read all printed documents identified on the Manager's Packet Checklist. Individuals listed on the roster who have not signed this contract will not be eligible to participate in the San Francisco Gay Softball League (SFGSL) for the season being registered.

Release (injury to myself or to my personal property)

I hereby released the following, in their individual and representative capacities ("released parties"). The (a) SFGSL and its sponsors, agents, players and officials; (b) SFGSL Board (individually and as a whole) from any and all claims, losses, liabilities, damages (including without limitation and damages to property, bodily injury or death), costs and expenses of any kind whatsoever, whether existing now or occurring in the future, arising from my playing, participation, or attendance or any SFGSL practice, game, activity, or event, or any negligence, error, action or omissions, to act by any "released party" (collectively referred to as "claims").

Hold Harmless (injury to others or other property)

I hereby indemnify and hold harmless the "released parties" from and against any claims.

Player Responsibility for Procuring Insurance

I am fully aware that the SFGSL carries no medical insurance for any participant and that I am solely responsible for securing my own insurance and that my team is responsible for securing its own insurance if deemed necessary.

Manager Familiarity with Rules

My manager has advised me that he/she has read the rules issued by the SFGSL and has advised me of the contents thereof.

Assumption of Risk

I assume all risks involved in my participation in the SFGSL, and I recognize that I am solely responsible for my decision to participate in any game in the SFGSL, and that the above release includes, but is not limited to, a release (a) for maintenance or condition of the playing area; (b) for condition of appurtenances thereto (courts, bleachers and gyms); and (c) for equipment supplied by the SFGSL.

Sports Skills

I am familiar with the skill required to participate in the League conducted by the SFGSL and have satisfied myself that I am proficient in these skills and that the above stated includes, but is not limited to, a release for failure of the SFGSL to provide classes for the technical instruction thereof.

Member Code of Conduct

I acknowledge that I have received, reviewed, and understand in full the Member Code of Conduct for the SFGSL. By signature on this Member Contract, I agree that I will conduct myself in accordance with terms of this Member Code of Conduct.

Manager's Statement

I hereby agree that I will manage my team in accordance with high standards of sportsmanship and require players recognize my authority for control of the team on the field and surrounding areas. Further, I understand that any player who has not signed the Member Contract is not eligible to participate in this League. I have read, understood and explained the rules under which this League will be played, to my players. I agree to accept and abide by the SFGSL rules and regulations.
